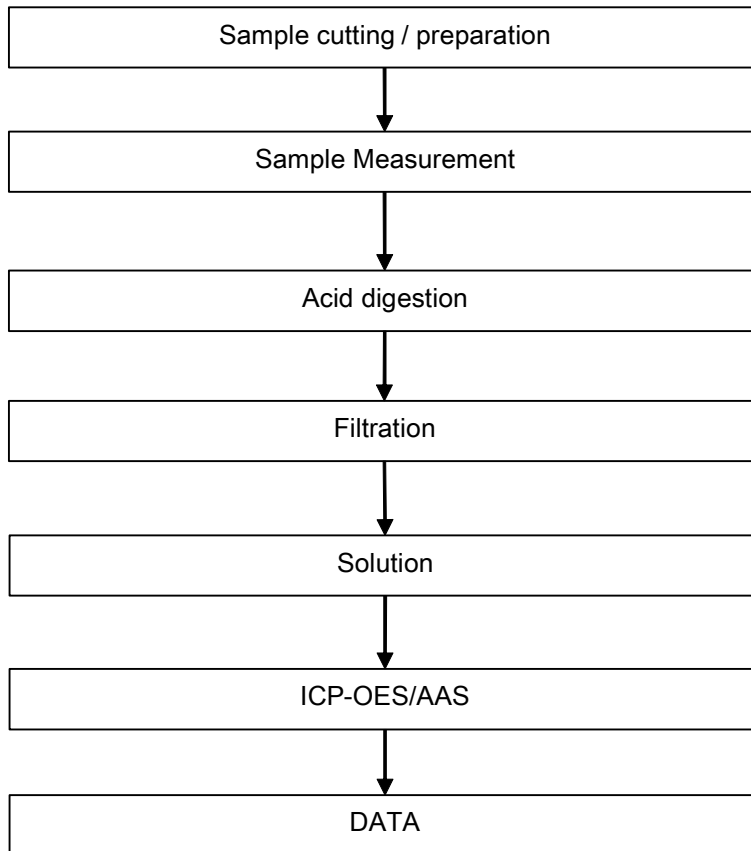

### Elementary Testing Flow Chart

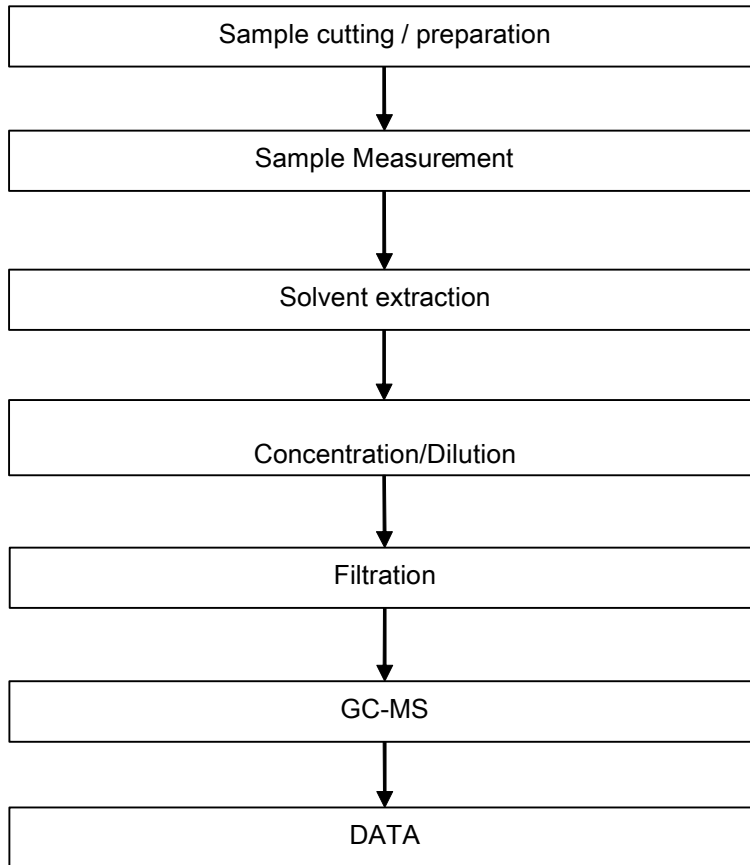
